OPEN Commitment to Justice, Equity, Diversity, and Inclusion



We are committed to building an environment that values everyone equally while addressing inequalities, including historical and contemporary injustices. We view optimal oral health and access to effective and affordable oral health care as a right rather than a privilege.



We are committed to **Justice**, **Equity**, **Diversity**, **and Inclusion** (**JEDI**) that includes a commitment to systemic change and the assurance of the structural and personal conditions needed to support equity and inclusion for all people.



We believe that a commitment to JEDI must be action-oriented. It includes applying a health equity and social justice lens to our oral health work and our personal thinking and practice. It requires building an ongoing practice of critical reflection within our organization and the broader systems perpetuating inequities.



No one of us as individuals and no one institution will be perfect. Still, at OPEN, we are committed to the practice of JEDI and helping each other be accountable to practices that foster an inclusive environment. Otherwise, we are in danger of reinforcing health inequities, often unintentionally.




We believe that JEDI is a process that requires continual reflection and commitment that is best understood through aligned action at the micro and macro levels.

- Diverse membership of oral health system stakeholders






OPEN Grassroots Definition





- CDC Division of Oral Health eliminated
- Chief Dental Officer at HRSA eliminated
- Medicaid bill moves through House mark up
- Executive Order on voting and Elections
 FDA taking action to remove fluoride supplements from the market
- Water fluoridation ban passed in two states: Utah and Florida

Choose a mentor based on shared interests or allow for automated match





State & Grassroots Committee

Committee Process in 2025



State & Grassroots Committee Meetings will focus on key topics of interest identified by OPEN through 2024 Annual Meeting feedback.



Committee Leads will workshop each topic as a small group and co-design ideas to support this collective work with help from subject matter experts.



During each Committee meeting, Reps will join breakouts to explore that day's topic from the lens of where they're working or where they'd like to grow.



Reps will report back on key strategies or resonating messages so that by the end of the year, we will have a repository of targeted feedback and recommendations



This repeat format will allow us to co-create a resource that reflects real experiences, strategies, and challenges from across the OPEN Network.

What Can Congress Do?





Action 1

Oppose Medicaid cuts that would jeopardize access to dental care for 72 million people who rely on the program.

- Medicaid is a vital source of dental coverage for children, people with disabilities, and low-income adults and seniors — improving health outcomes, reducing medical debt, and boosting economic opportunity and job performance.
- Cuts to Medicaid funding would force states to eliminate adult dental benefits, leading to increased emergency room use, reduced services or closures of safety net dental providers, and higher system-wide health care costs.



Action 2

Improve access to dental care for veterans who get medical care through the VA.

- The majority of veterans do not qualify for VA dental benefits, and those who do often face provider shortages, geographic barriers, and high out-of-pocket costs — placing them at greater risk for chronic conditions and financial strain.
- Nearly 8 million veterans report fair or poor oral health, with rural and disabled veterans disproportionately affected due to limited provider access and higher care costs.¹



Action 3

Support the HEADs UP Act, which would designate people with Intellectual and Developmental Disabilities (I/DD) as a Medically Underserved Population (MUP) and increase their access to oral health care.

- Individuals with I/DD face worse oral health outcomes reporting less frequent dental visits and higher rates
 of discrimination and emergency dental care use than those without disabilities.²
- Designating the I/DD population as a Medically Underserved Population would expand access to tailored services
 through health centers, enhance provider training and support, and unlock targeted federal funding to address
 long-standing access gaps including in oral health care.
